

Minutes of the January 20th, 2025 City Council Meeting *Unofficial meeting minutes until approved by Council*

The regular meeting of the Robins City Council was called to order at 6:00p.m. on Monday, January 20th, 2025 at Robins City Hall, 265 S. 2nd St by Mayor Chuck Hinz. Following the Pledge of Allegiance, roll call was taken with the following members present: Councilor Leigh Cook, Councilor Mike Foley, Councilor Dave Franzman, Councilor Cary Smith and Councilor JD Smith. Also present were City Clerk Lisa Goodin, Deputy City Clerk Rhonda Kortenkamp, City Attorney Holly Corkery, Police Chief Andy Humphrey, Fire Chief Keith Feldkamp and Building Official/Public Works Superintendent Mike Kortenkamp.

Franzman moved to approve the agenda, J. Smith seconded and all voted aye.

CITIZENS' COMMENTS – AGENDA ITEMS: None presented CITIZENS' COMMENTS – NON-AGENDA ITEMS:

Matt Gavin of 320 Shannon Dr. inquired into the possibility of the City removing snow from the trail at South Troy Park during the winter months. Mayor Hinz replied that the City has not historically plowed park trails, following the same procedures as the used for the Cedar Valley Nature Trail. Foley commented that as the trail is not ADA compliant, snow removal is not required.

J. Smith moved to approve the Consent Agenda, which contained the Minutes of the January 6th City Council meeting and the List of Bills Submitted Foley seconded and all voted aye.

- C. Appointment of Vance McKinnon as P&Z Administrator. Motion made by Franzman, seconded by J. Smith. All votes were aye.

OLD BUSINESS:

Mayor Hinz noted that Scott and Goodin continued work on an updated 5-Year CIP. Goodin noted the changes to the budget calendar to reflect the upcoming Levy Vote. Additional Council Budget Work Sessions were scheduled for February 10^{th} & February 24^{th} . Goodin provided an update on the City Hall remodeling and provided an updated schedule for the improvements.
